
"Now during those days Jesus went out to the mountain to pray; and he spent the night in prayer to God." ~Luke 6:12

(We will gather "Rain or Shine" — but will have our picnic in Cox Hall and Evening Prayer in the Church Sanctuary in case of inclement weather).



One hundred parishioners gathered for a Parish Meeting on Sunday, May 17th, in Cox Hall, immediately following the 10:30 Worship Service, to hear a report on the "State of the Parish". Following an opening prayer by the Rector, Becky Hoecker, Senior Warden, opened the meeting with a brief overview of the organizational structure of the church and the roles of the Rector, the Vestry, and the Finance and Endowment committees.

Carol Miller, Chair of the Finance Committee, gave a detailed report on the current state of the finances of the Parish. Using slides to illustrate her report, Carol explained the trends in pledging for the past several years. Pledging has gradually declined as endowment growth has gradually risen. Currently, pledge cards received for 2015 is down by 28 pledge cards from last year. This decline will soon create a financial crisis for the Parish if it is not turned around.

Carol further explained Parish expenses and how these expenses have been met in the past and are being met today. She also explained how many maintenance and repair issues are balanced or delayed because of a lack of funds.

Carol closed her presentation by reminding us: "All things come from thee, O Lord, and of thine own have we given thee."

Guy Dove, Chairman of the Endowment Committee followed Carol with a history and overview of the committee. Guy explained the purpose of the endowment is to preserve and enhance its real, inflationadjusted, purchasing power while providing a steady and consistent spending stream to help support the church's missions. He explained the committee's objective is to maximize investment return with reasonable and prudent levels of risk consistent with achieving long-term growth and preservation of capital.

Guy reported the Endowment had recommended a 4.5% draw for 2015, consistent with trends in other endowment funds based on the current market. However, because of the needs of the Parish, the Vestry voted a draw of 5%. The Vestry will reconsider the draw in June when it considers the mid-year budget adjustments.

Gray Coyner defined the role of the Trustees in the sale of church property. Trustees hold legal title of the real estate for the church and are selected by the Vestry, which then must present the selected candidates to the Circuit Court for appointment. The Trustees represent the Vestry and the church.

Gina Hammond reported on Stewardship and illustrated by slides detailed stewardship data, once again showing the loss in pledges and the need for additional income

Gina gave a report on the expenses of the Gulick House (the old Rectory) that has been a topic of much conversation recently. Following the tenants vacating the house last October, repairs were needed, pipes burst in the winter and concerns were raised about the soundness of the foundation. Currently, the Vestry is receiving estimates on costs for needed repairs and renovations. Once the estimates are in, the Vestry will weigh the costs against the costs of possibly selling the house and investing the proceeds in the endowment for future growth. The results will be presented to the Parish for discussion and a possible vote.

The Rector gave a brief report on the call for an Assistant Rector. He said an assistant rector for Trinity needed strong skills in liturgy, pastoral relations, and technology-based programs and ministry outreach. As church dynamics change, and as Trinity becomes more and more a destination church rather than a neighborhood church, skills in outreach and technology are becoming more and more important.

Following question and answer period and comments from the congregation, the Rector closed the meeting with a prayer.

VESTRY NOTES

The Vestry met for its monthly meeting on Wednesday, May 20th at 6 o'clock. Rob opened the meeting with prayer that was followed by the recitation of the Lord's Prayer. Joe Fluet presented a Bible study based on Luke 7:11-17, Jesus raising the widow's son. Joe explained how this scripture, and others, are used as tools in the Healing Ministry class.

The minutes of the April 15th meeting were approved, and the Rector introduced Mayo Brown, Secretary/Warden of the Trinity Church Cemetery Corporation.

Mr. Brown gave a brief history of the Cemetery Corporation to the Vestry that was followed by a question and answer period. Mr. Brown has been involved with the cemetery since the idea was first presented by Mr. and Mrs. Mellon to the late rector, Dick Peard. The cemetery was consecrated in 1995. Mr. Brown said the cemetery now has 380 grave sites available out of a total 550. The Cemetery Corporation pays the church for the services of Tommy Breeden, the Sexton, for mowing and maintenance. The Vestry and the Rector thanked Mr. Brown for his long and uninterrupted service to Trinity Church.

Charles Ince presented the Treasurer's Report. Currently, pledged income is ahead of that collected at this time last year, but as total amount pledged is below last year's pledged amount, the income will level out in the coming months. At this time, Profit and Loss Statements and Balance Sheet look as expected with no extraordinary expenses to report.

Carol Miller, Interim Chair of Finance, gave the report of the Finance Committee. Carol recommended the re-election of David Hartley and Jeff Hood to the Endowment Committee, both for a three-year term ending April 30, 2018. She also recommended the confirmation for the terms for the remaining at-large members: Stanley Dees to a term ending April, 30, 2017; Guy Dove and Bradley Gable to terms ending April 30, 2016. The Vestry unanimously approved the recommendations.

Carol distributed and briefly reviewed several documents to the Vestry regarding existing policies of Trinity Church and The Episcopal Church regarding financial management and business practices in church affairs, and gift policy.

The first order of New Business was the unanimous approval by the Vestry of David Hartley as interim Vestryman to replace John Johnson who resigned in May.

The Vestry briefly reviewed the Parish Meeting held on May 23rd and expressed their gratitude to the many parishioners who attended (101 were counted) and to those presenting reports. The Vestry reported the strong positive response by parishioners and the hope that another such meeting will be held in the next few months.

The Rector announced his plans for the summer. He will participate in a continuing education program for clergy as well as go on a bicycling vacation with his family. The Reverend Jim Hammond will be conduct services during Rob's absences.

The Vestry voted to cancel the Shrine Mont retreat. The scheduled speaker, the Reverend Debbie Royals, will present her program at Trinity Church on the same weekend of the previously scheduled date for the retreat, June 12th-14th.

The Vestry briefly discussed the need for an assistant Rector and endorsed moving forward in search of a good candidate.

The Nominating Committee for new Vestry candidates reported that it is making calls and talking to members of the church and hopes to present the slate of candidates to the Vestry by July.

Gina Hammond reported on the current state of stewardship and the hope that parishioners will increase their pledge by 10% to meet the needs of the church. You may increase your pledge by amending your pledge with a new pledge card, by submitting a check for the increased amount with a note on the memo line to that purpose, or by credit card. For further information, please contact Beth Rogers.

Dan Murphy has graciously agreed to be Chairman of Stewardship Committee this year and will soon put together a committee for that purpose. If you are interested, please contact Dan. Stewardship is a very difficult, demanding, and greatly rewarding task, and it needs our support and our time. The Vestry is grateful to Dan for his willingness to lead the church in this effort.

The Wardens extended their thanks to all the members of the church for their support of Trinity Church and the recently held Parish Meeting and to the participants: Carol Miller, Guy Dove, Gray Coyner and Ellen Hall. They also thanked Stanley Dees and Jonathan Catherwood for their behind the scenes work providing information and materials for the meeting.

Rob closed the meeting with a prayer.

DID YOU KNOW?

Little known facts about Trinity Episcopal Church - Upperville, VA

We have just finished a very successful Stable Tour and it may be an opportune time to take a break from the Trinity buildings and mention a bit of history of the Stable Tour or the "Hunt Country Farm & Estate Tour" as it was first known. The first tour was held on November 7, 1959 and began as a house tour featuring four of the area's prominent houses, gardens or stables. The ticket price was \$3.50 for both days.

Brookmeade Racing Stable and the first floor of the Brookmeade house was one stop, the Heronwood Topiary Gardens another, the Catesby Greenhouses, a third and finally, Ayrshire with the first public showing of the silver used at the Arlington and Lexington homes by General and Mrs. Robert E. Lee. The ladies of the Mary D. Neville Guild served lunch in the new Parish Hall for an additional \$1.50. No tours of the church were given as it was still under construction.

The church had so little money in those days the Vestry decided not to have any fundraisers until 1965 when Mr. and Mrs. Reed Thomas and Mr. and Mrs. George Robert Slater conceived the idea of a "Stable Tour" and it has been an annual event ever since.

Meanwhile, Mark Thompson once again took over all sink duties and Len Shapiro mastered the green beans. On the serving line and handling all the baked goods were Gina Hammond, Hilary Bateman and Ann MacLeod. John and Louisa Barker proved valuable on the serving line, along with our four young charges: Claire Thompson, Madison Peck, Inara Junkala and Maura Thompson. Robin Keys was also on hand.
